Chain speed was 390 head per hour, running two shifts of operation. Site slaughtered approximately 6,000 head per day operating five to six days per week.

Comment:	Animal Welfare Program and Cattle Haulers Animal Handling and Welfare Procedure Manual defined guidelines and expectations for cattle receiving. Cattle haulers signed the Head Count Verification sheet with the arrival of each load, which indicated understanding of facility expectations, including that they be BQAT certified.	
1.2	Must provide extreme temperature management tools for both hot and cold weather. In hot weather air movement or other temperature management tool such as natural ventilation or keeping trucks moving.	yes
Comment:	Quality Management Program included that if cattle were hauled at high temperatures with high humidity, transporters were directed to deliver cattle to the plant with a minimal amount of stops and/or adjust the density of the trailers. During summer months the facility may adjust arrival times to limit cattle wait times. Sprinklers could be used when over 70 degrees Fahrenheit to help in hot weather. Slats could be used in trailers during cold weather.	
1.3	A policy is in place assisting in the arrival management process, minimizing the waiting time at the plant, (plant should have the lairage space and personnel to meet the requirements of the policy). Note any extenuating circumstances if written policy is not met at the time of the audit.	yes
Comment:	Deliveries were scheduled through cattle procurement to reduce cattle wait times at the facility. In the event of plant break downs, drivers were contacted and instructed to keep driving to maximize airflow or were diverted back to the feedyard.
